A. CALL TO ORDER & INTRODUCTIONS: Vice Chair, Sharon Fornaciari called the meeting to order at 7:00 pm.

B. APPROVAL OF MINUTES:

MOTION: It was moved/seconded (Ratchuk/Hagen) to table the approval of the June 2, 2015 minutes until next meeting. Motion passed: Ashcroft, Farinsky, Fornaciari, Hagen, Maurer, McGuire, L. Pacelli, and Ratchuk. Against: None. Abstain: Bernstein, Collins, Hooshidar, Martini, and Wilsev.

C. COMMUNICATIONS: Center Director Salome Martinez stated Hal Sherman will be representing CVLAX in the absence of Don McGuire.

D. PUBLIC FORUM: Resident and Neurologist, Emily Engel voiced her concerns about the toxins from artificial turf, the toxins from the chemicals used to maintain it and the mold/diseases that can develop from it; these toxins can cause irreversible neurological damage. She opposes the replacement project of natural grass turf to artificial turf in the Carmel Valley area and asked the board to consider the health issues. Ms. Geraldine Sandberg, resident of Carmel Valley and nurse, also voiced her disapproval of the artificial turf project and stated her concerns about the neurological diseases that are caused by it; she really wants the council to think about these concerns when discussing the artificial turf projects.

E. STAFF REPORTS:

Pool Manager, Bradley Cannon informed the pool is up and running with six new lifeguards added to his staff. He stated their biggest growing program is the water polo team as it has tripled since last year and he has added two new coaches to accommodate growth. He mentioned registration is going smoothly on the ActiveNet online registration system.

Center Director, Salome Martinez communicated summer camps are going strong and she is now working on the fall 2015 brochure. She reported the Movie in the Park event on June 27, 2015 with featured movie Despicable Me 2 was a success with over 400 people in attendance. She mentioned staff promoted the Park Fit program at the movie event and there are over 50 people signed up for the program. She informed the featured movie for the August 15, 2015 movie in the park event had to be changed from Cinderella to Toy Story; release date for Cinderella was delayed.

Area Manager, Sarah Erazo reported the City of San Diego Park and Recreation Department has cut water more than 16 percent since the reductions started; she is hoping to adjust irrigation times if possible. She informed she will be doing a partial mini renovation on Sage Canyon joint use field which will include leveling it out, dethatching it, and adding sand and topsoil. She thanked the Del Mar Little Leagues and Yoga instructor Janice Sherman for their Park Fit 5K Fun Run donations; she invited everyone out to the Park Fit 5k finale event on August 22, 2015 to enjoy all the fun festivities, booths, entertainment, and raffle.

<u>F. CHAIRPERSON'S REPORT:</u> Marilee stated she sent out an email with an attachment of the Summer Serenades Concert series and asked all members to help distribute the flyer and get the word out.

G. TREASURER'S REPORT: Greg Ratchuk passed out the financial report and reported the ending balance as of July 7, 2015 as \$412,789.02.
