

SLOPE EASEMENT & BUILDING RESTRICTED EASEMENT VACATION

ALL OF THE SLOPE EASEMENT AND BUILDING RESTRICTED EASEMENT GRANTED TO THE CITY OF SAN DIEGO PER RANCHO DEL SOL UNIT 1, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO MAP THEREOF NO. 12477, FILED IN THE OFFICE OF THE COUNTY RECORDER OF SAID SAN DIEGO COUNTY ON OCTOBER 18, 1989 LYING WITHIN LOT 31 OF SAID MAP, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

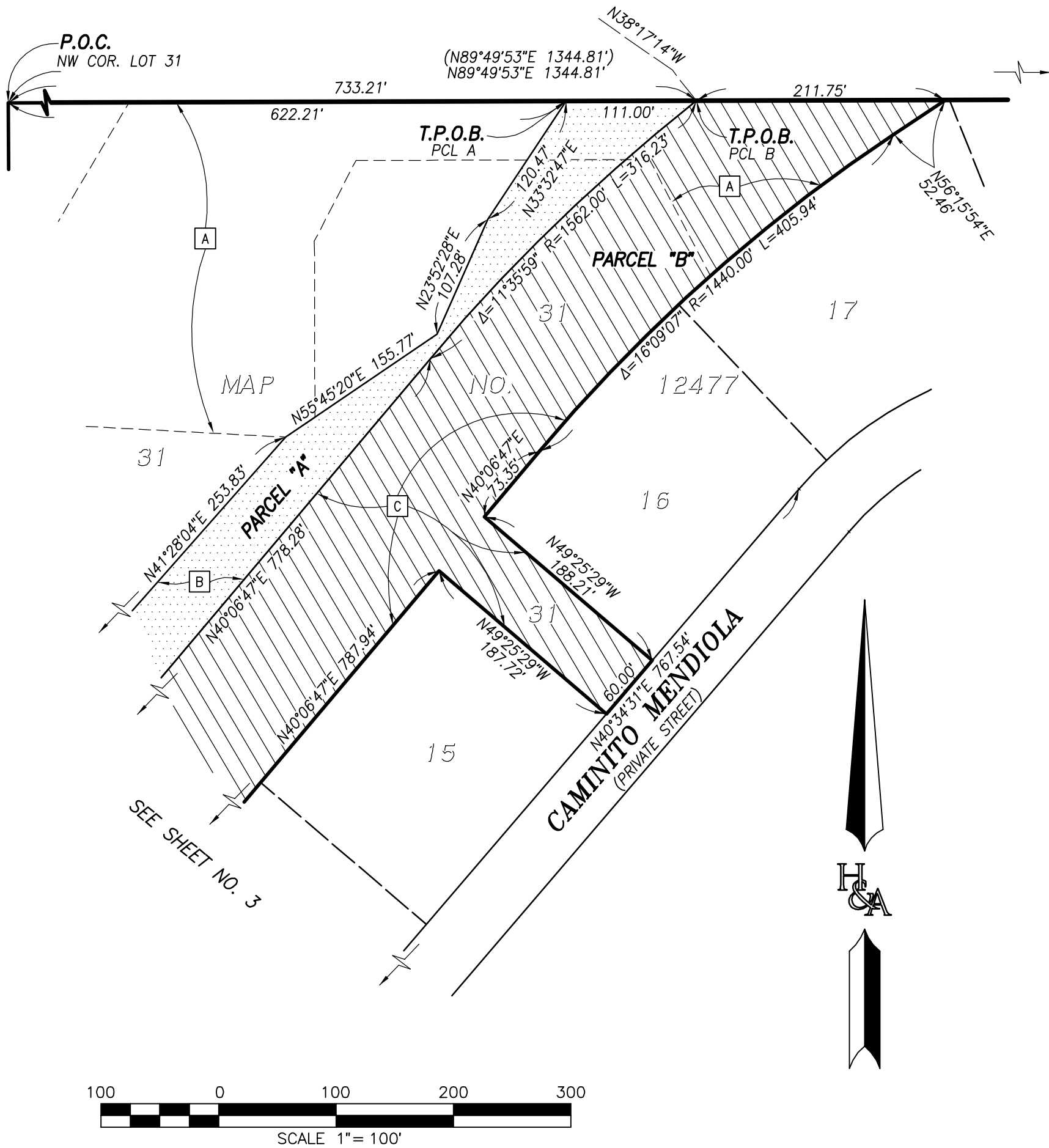
